■ Award Overview and Evaluation Points

The "NIKKEI Integrated Report Award" aims to further enhance and promote integrated reports published by Japanese companies. Evaluations are conducted from multifaceted perspectives by a rigorous panel of judges, including fund managers, analysts, and academic experts. In this 5th edition, a record 504 companies and organizations participated. From this group, the following awards were presented: three Grand Prizes, one Sustainability Prize, one Governance Prize, nine Semi-Grand Prizes, one Rookie of the Year, two Legend Prizes, and 48 Excellence Awards.

Our "Integrated Report 2025" was designed to foster a deep understanding and facilitate constructive dialogue with all stakeholders by outlining the path toward corporate value enhancement based on our new Medium-Term Management Plan. The following points were particularly highly regarded during the screening process:

- **Clarification of a new value creation story**

Under the theme "Co-creating and Sharing Value" for the new Medium-Term Management Plan (Fiscal year ending March 31, 2026, to Fiscal year ending March 31, 2031), we refreshed our value creation process. Our logical and easy-to-understand expression of the story behind creating corporate value was highly evaluated.

- **Visualization of the link between non-financial information and financial performance**

Our advanced approach was praised for its attempt to quantitatively clarify and disclose the complex relationship between non-financial capital and financial performance through data analysis (such as SHAP and simulation analysis).
